946c	Marathon Anacortes Refinery	Skagit	01/19/24	Modification to permit to remove obsolete requirements and replace periodic stack testing for CO and NOx with continuous emission monitors. No physical modifications to equipment and no new equipment.
1177a	Safway Services LLC	Whatcom	01/23/24	Modification to existing paint spraying and abrasive blasting operations to include different paint formulations, update usage amounts, and modify the dust collection and filtration system.
1418	Janicki Industries Inc	Skagit	01/25/24	One plasma cutter for cutting steel and invar alloy. Cutting will take place on a water table with an overhead fume extractor routed to a filtration system.

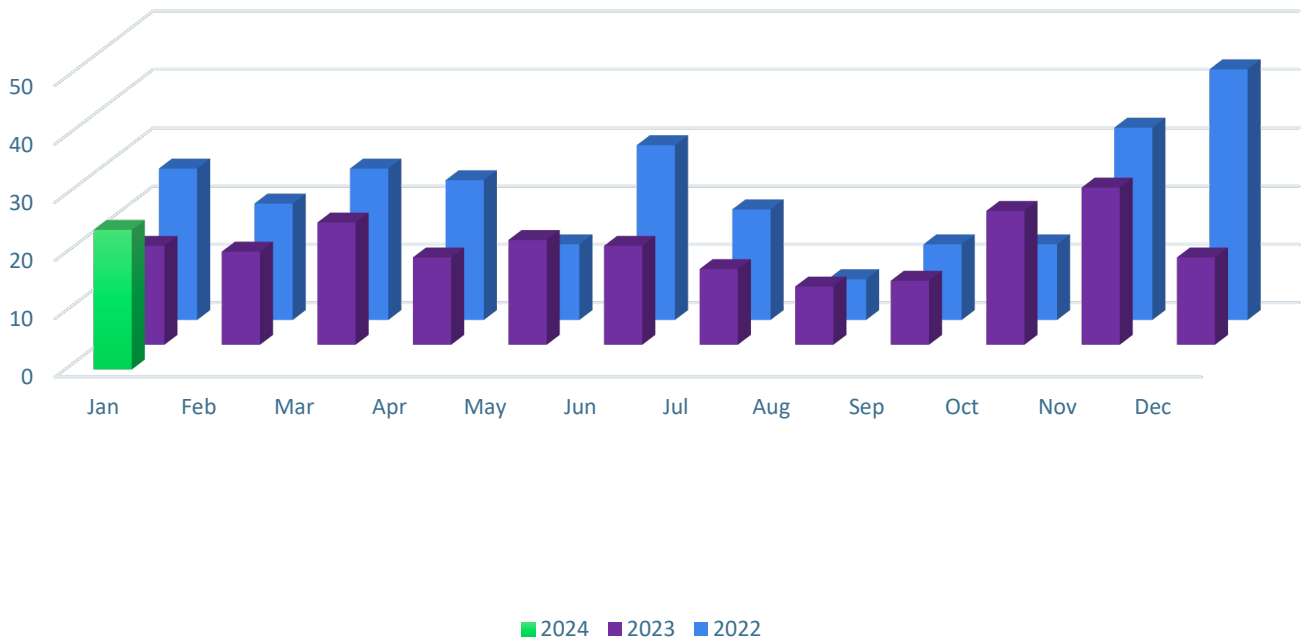

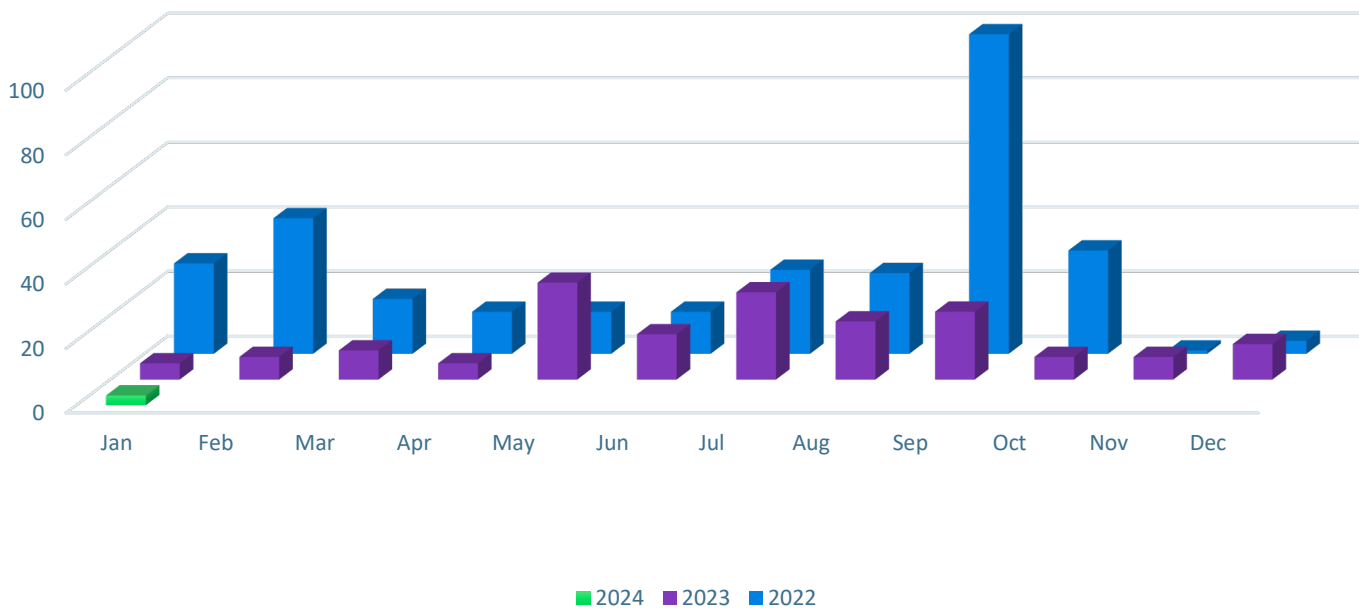
