- 6. Wood stove replacement update -

Mark – There are 5 households already in the application process and 10 on the waitlist.

Seth – Passed on another contact just today to be added to the list. The list of woodstoves approved to be put into homes has been reduced to those models that meet stricter testing performed by the State of Alaksa. Only models that are currently on an EPA-approved list based on the Alaska testing will be used.

- 8. Possible outreach Opportunities and chipping event -

Rebecca – Currently cannot look for funding for the chipping event. She will try to write up what she has done in the past so that the group can find a way to take up the slack and possibly get the event up and going again. The East Whatcom Community Council has been asked to sponsor the event but is not sure it is a good fit.

Aly - Possibly shifting the chipping event over to the park and recreation district.

Seth – NWCA can help with funding because the event aligns with their mission up here.

Rebecca – The cost through the current vendor is about \$2,500 to \$3,000 per day. Peaceful Valley is certified "firewise" so the HOA has been paying for their chipping event separately.

Seth – NWCAA is talking about possibly finding a way to do an event that may be a standalone or attached to an event like the Health Fair but with more presence. This would be like an event NWCAA and the Clean Air Committee held in 2017 to talk about implementing burn bans during poor air quality periods. The group talked about possibly reaching out to Barron and having them bring out a Vermont stove to be at the event.

9. NW Clean Air update -

Seth – There were seven exceedances in November: 11/17: 47.6, 11/18: 57.3 ,11/25: 48.8, 11/26: 58.4, 11/27: 65.2, 11/28: 45.2, 11/29: 40.3.

There were 2 complaints from November 1 through December 12 – one fireplace on Juniper, the other outdoors on Overland Trail.
