

# Northwest Clean Air Agency (NWCAA) REGISTERED SOURCE FEE SCHEDULE (NWCAA 324.1)

## Effective January 1, 2024

Approved by the NWCAA Board of Directors on November 18, 2021, under Resolution 594

#### Notes:

Unless noted otherwise, all annual emissions referenced here exclude carbon monoxide and greenhouse gases and are rounded to the nearest one-tenth of a ton.

Actual annual emissions, gallons of gasoline pumped, and wet tons of composting feedstock are determined for the preceding calendar year (e.g., 2018 fees are calculated using 2016 actual emissions or gasoline throughput or wet tons of feedstock).

*Failure to provide actual annual emissions/usages or throughput information may result in the agency using potential-to-emit (emissions resulting from operations 24 hours per day, 365 days per year) to calculate fees.* 

This fee schedule is adjusted annually as described in Resolution 594.

#### Attachment: Complex 1 and 2 Listing

Multiple fees within a complexity may apply; for example, the complexity fee for a portable rock crusher subject to 60 Subpart OOO powered by a 450 hp diesel generator subject to 63 Subpart 4Z is subject to the Complex 1 fee multiplied by 3. Descriptions within the complexity listings apply on a facility basis unless specified otherwise.

#### Complex 1

- Composite (fiberglass) fabrication and surface coating operations utilizing rolling average/weighted average limits to meet compliance (excludes synthetic minors).
- 5 to 20 nuisance complaints<sup>1</sup>/year
- Portable source
- Code of Federal Regulations (CFR) Title 40:
  - 60 Subpart Ja Petroleum Refinery Operations
  - 60 Subpart Kb Petroleum Storage Tanks per tank
  - 60 Subpart UU Asphalt Processing and Roofing Manufacturing
  - 60 Subpart OOO Rock Crushing
  - 63 Subpart M Perchloroethylene dry cleaners
  - 63 Subpart N Chromium Electroplating
  - 63 Subpart 4Z (small) RICE Engines (greater than 300 hp, and less than or equal to 500 hp nonemergency, non-limited use) – *per engine, for first three*
  - 63 Subpart 6B Bulk Gasoline Terminal
  - 63 Subpart 6J (small) Boilers (less than 10 MMBtu/hr other than natural gas-fired) per boiler, for first three
  - 63 Subpart 6Q Wood Preservation
  - 63 Subpart 6W Metal Plating and Polishing

### Complex 2

- More than 3 Orders (e.g., Order of Approval to Construct (OAC), General Order, etc.), but excluding Synthetic Minor Orders under WAC 173-400-091
- More than 20 nuisance complaints<sup>1</sup>/year
- Code of Federal Regulations (CFR) Title 40:
  - 60 Subpart Dc Boilers (greater than or equal to 30 MMBtu/hr wood-fired) per boiler, for first three
  - 63 Subpart 4Z (large) RICE engines (greater than 500 hp non-emergency, non-limited use) per engine, for first three
  - 63 Subpart 5Z Iron and steel foundries
  - 63 Subpart 6J (large) Boilers (greater than or equal to 10 MMBtu/hr other than natural gasfired) – *per boiler, for first three*
  - 63 Subpart 7A Asphalt Processing and Roofing Manufacture
  - 63 Subpart 7D Animal feed
