- *only available in certain areas east of Sedro-Woolley*

This offer is not available to multi-family housing such as apartments and condos or to current WM customers. By completing the form, you consent to the information being shared with WM to set up a free trial account paid by Northwest Clean Air Agency (NWCAA). Unless you opt out, at the end of the free trial period WM will set up an account in your name that will be billed directly to you.

You may elect to opt out at any time during the 6-month trial period*, but no later than 45 days prior to the end of the trial period, to avoid paying for continued curbside garbage pickup service at the end of the program.
